

## Preliminary Analysis

- Analyzing State statutes and rules governing novice driver education standards to understand the State's current status and where the State meets, exceeds, or does not meet the NTDETAS.

## Post Analysis

- Determining how the State may adopt the NTDETAS without the need to adopt statutes and/or rules.
- Determining how to establish short-term, mid-term, and long-term goals in meeting the NTDETAS.
- Determine funding potential from federal, State and tuition sources for driver education programs.
- Providing samples of recent student programs for classroom and behind the wheel from other States and organizations.

## What are State Consultation Services?

- Is available, **at no cost**, for any State wanting to meet any components of the Novice Teen Driver Education and Training Administrative Standards (NTDETAS).
- May be conducted prior to a NHTSA State Assessment / Peer Review.
- Can provide a preliminary analysis of a State's driver education program.
- A State may then utilize highway safety funds, or other funds, to conduct a NHTSA State Assessment / Peer Review based on the recommendations in the NTDETAS.
- ANSTSE can provide post analysis State Consultation Services after a NHTSA State Assessment / Peer Review to assist with meeting the recommendations given.
- Can be provided either onsite or offsite.
- Facilitated by the ANSTSE Secretariat and conducted by experts in driver education.



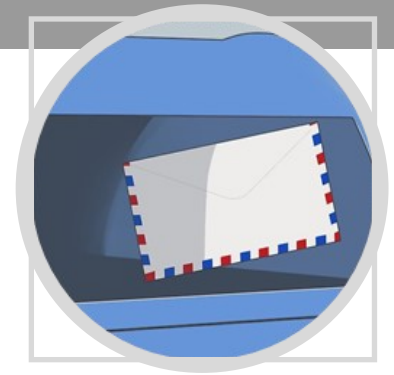
## Offsite Consultation Services

- ANSTSE can provide education remotely and can also refer states or individuals to Association members for additional consultation services.
- Can be provided through telephone calls, web meetings, e-mail with ANSTSE Secretariat, ANSTSE members, other experts in the field, and other State contacts.
- An Association website, [www.anstse.info](http://www.anstse.info) has been developed to assist in providing State Consultation Services.



## Onsite State Consultation Services

- The ANSTSE Secretariat will assign one to two experts to travel to the State to possibly meet with State officials.
- ANSTSE will cover the travel expenses for experts to provide consultation services.
- The meeting will be approximately 2 ½ days in length. The first two days will be to meet with the State officials and the half day will be a report out on the recommendations provided.
- A report will be submitted detailing the visit, recommendations provided and suggested actions to undertake.



## Requesting State Consultation Services

- Provided by contacting the ANSTSE Secretariat and sending a formal letter of request from the State.
- The letter should explain the goals of the State Consultation Services and what your State would like to gain from the consultation services.
- If there are certain areas you would like to focus on (i.e. instructor training, program administration), include that in the letter as well.
